STUDENT DORMITORY UNDERTAKING AGREEMENT

1. The period of accommodation in the dormitories covers the dates between 28 September 2026 and 22 June 2027, that monthly payments for the entire period are mandatory, and that if I leave the dormitory without an acceptable reason, my future dormitory applications will not be accepted and I will lose my right to accommodation.
2. If I fail to complete the Preparatory School within two semesters, my deposit will be refunded and my relationship with the dormitory will be terminated. If I wish to benefit from the dormitories again, I must submit a new application.
3. If I exceed the absenteeism limit specified in the ITU Undergraduate / Associate Degree Education and Preparatory School Regulations, my accommodation rights will be terminated.
4. If I stay outside the dormitory overnight without permission and without informing the dormitory administration, I accept that the administration may inform my family.
5. I will not possess or consume alcoholic beverages, narcotic drugs, or stimulants in the dormitory buildings or surrounding areas, and I will not participate in gambling activities.
6. If I damage any fixed assets or dormitory property, deductions may be made from my security deposit.
7. I will comply with standards of courtesy and good conduct; I will not behave rudely, disrespectfully, or in a manner that disturbs others; I will not make excessive noise, listen to loud music, or watch television at high volume. Likewise, I will not play any musical instrument outside the halls designated by the dormitory administration and will not sing in a manner that disturbs others.
8. I will receive guests only in the lounges designated by the dormitory administration and will not accommodate overnight guests in my room.
9. If I cause damage to furniture, equipment, or facilities in my room or in common areas, I will compensate for such damage based on the current replacement cost on the date of payment. If I fail to make payment on time, the amount may be deducted from my security deposit.
10. I will not use fire extinguishers or alarm buttons for purposes other than emergencies.
11. I will keep my room and other dormitory areas clean and orderly. I will not keep odorous, leaking, or perishable food items in wardrobes and will not use electrical appliances within the dormitory building.
12. I will not occupy any room, bed, wardrobe, desk, chair, or other property other than those assigned to me.
13. I will not display pictures, posters, or materials contrary to public morality in my room or anywhere in the dormitory.
14. I will not keep pets in the dormitory.
15. I will comply with the rules of the Zero Waste Management System Plan administered by the ITU Waste Commission and will take due care in separating recyclable and non-recyclable waste.
16. I will not interfere with the duties of dormitory staff, will not engage in behavior that obstructs their work, and will treat them with respect.
17. Upon request by university personnel or security officers, I will present my ITU identification card.
18. I will scan my card at the turnstiles when entering and exiting the dormitory.

19. I acknowledge that safeguarding my personal belongings is my own responsibility and that the dormitory administration assumes no liability for any loss.
20. I will comply with the schedules determined by the dormitory administration regarding dormitory entry and exit, TV lounge use, laundry facilities, and other services.
21. If the dormitory building to which I applied is not opened due to insufficient occupancy, or if it is closed during semester breaks, extended holidays, or for any other reason, I agree to stay in the dormitory building assigned by the administration.
22. I will pay the dormitory fee by the 5th day of each month, or by the end of the next business day if the 5th falls on a holiday, into the bank account designated by the administration and submit the payment receipt to the dormitory management.
23. If I fail to pay my dormitory fee, I will be notified and granted a period of 10 days to make payment. If payment is still not made within this period, I will receive a warning. If I receive such a warning twice during one academic term, my accommodation rights will be terminated.
24. If I am expelled or removed from the dormitory, I will not be entitled to a refund of the dormitory fees I have paid.
25. Upon the expiration of this undertaking and my departure from the dormitory, my security deposit will be refunded within one month after an inspection confirms that there is no damage to my room.
26. I will complete the registration renewal process announced on the dormitory website and pay the required fee if I wish to continue staying in the dormitory the following year. If I fail to do so, my accommodation rights will be terminated and checkout procedures will be completed.
27. I accept Article 14(d) of the Dormitory Directive, which states: “Students may take a maximum of 20 days of leave during a semester, excluding weekends and official holidays, without a valid excuse. No reduction in dormitory fees shall be made during this period. For students exceeding 20 days of home leave in one semester, the Dormitory Management Board may initiate the process of removal from the dormitory.”
28. I understand that if I fail to comply with the provisions stated above, the ITU Student Dormitory Directive, or any other dormitory-related decisions made by the University, disciplinary action may be taken against me by the Dormitory Management Board. As a result, I may be expelled from the dormitory, and my academic unit may also initiate a separate investigation.
29. I accept all articles and provisions of the Ministry of Youth and Sports Regulation on Private Higher Education Accommodation Services, dated 30 October 2024 and numbered 32707.
30. I confirm that all documents and information uploaded to the system as part of my dormitory placement application are accurate and truthful. If any false or misleading information is detected, my placement may be canceled and the necessary procedures for removal from the dormitory may be carried out
